**CONSECRATION SUNDAY
GUIDELINES FOR COMPENSATING GUEST LEADERS AND SPEAKERS**

Guidelines for compensation for trained Consecration Sunday guest leaders and speakers:

- One-hour planning meeting with stewardship team \$160
- Speaking at church leader meeting
Includes meeting immediately prior with program leaders \$160
- Guest preaching (current synod guidelines)

1 service	\$125
2 services	\$160
3 services	\$200

appropriate increase should be provided when there is a service at another time in addition to Sunday morning, e.g., Saturday evening, Thursday evening.

- Travel and any other expenses actual cost reimbursed
